The Medesto Connect is a compact design to sit on a countertop, end table, bed side or taken on the go, to provide connectivity and audio and visual reminders. Scan NFC smart tagged medications or cards to indicate usage taken that day. The Medesto Dispenser is designed to dispense solid medications from the pods and when connected to WiFi and the app, tracks the doses taken or missed.

Medesto Pods can be organized and filled at our in-house pharmacy, Perigon Pharmacy 360, and sent directly to patient or local pharmacies with Medesto Pod filling, contact your doctor to transfer your pharmacy.

The Medesto App makes adherence easy with notifications when it's time for a scheduled dose, as well as alerts for missed doses.
